In accordance with Articles 34.1 and 34.3 of the AFC Disciplinary and Ethics Code, USD50,000/- of the amount referred to in Paragraph 1 of this Terms of Decision is suspended for a probationary period of two (2) years. 3. Afghanistan Football Federation is fined USD4,500/- for violating Article 55.1 of the AFC Disciplinary Code (2014 Edition) (the "2014 Code") in the following matches: 1.1 United Arab Emirates vs. Afghanistan on 2 October 2015 1.2 Afghanistan vs. Palestine on 4 October 2015 1.3 India vs. Afghanistan on 6 October 2015 2. The fine shall be settled within 30 days from the date that this decision is communicated in accordance with Article 11.3 of the AFC Disciplinary and Ethics Code. 3.
