The fine shall be settled within 30 days from the date that this decision is communicated in accordance with Article 11.3 of the AFC Disciplinary and Ethics Code.</p> <p>6.Mr. Abdelkarim Hassan A Fadlalla (AFC/15819/QAT) is informed that a repeat violation of this provision may be met with more severe punishment.</p> | VTC 20191021DC01 |
